RULES FOR SPARKIES AND JUNIOR FIREFIGHTERS

- 1) Sparkies will be between the ages of 14 and 16. Juniors will be between the ages of 16 and 18. Openings will be limited to 10 members.
- 2) Applicants must have written consent by a parent/guardian prior to being voted upon for membership. An FVFC officer will have a meeting with the parent/guardian to discuss all rules/regulations regarding the membership being applied for.
- 3) Line Officers and designated regular members will be in charge of the applicants.
- 4) The fire company will not at any time interfere with school work or attendance. Applicants will be expected to maintain a 2.0 GPA. They will also not be permitted to be on fire company grounds or incidents during regular school hours, or after 10 PM on school nights.
- 5) During an emergency call, applicants will respond to the station in a non-emergency manner. Applicants will never respond directly to the scene of any incident.
- 6) Applicants will not be allowed to operate any fire/EMS apparatus at any time.
- 7) Applicants will be allowed to participate in all company functions including trainings. They will be closely monitored by the company Line Officers and regular members.
- 8) Sparkies will never be on any apparatus responding in an emergency manner.
- 9) Juniors will not respond on the first apparatus, however will be allowed to ride any other units that respond to the scene of an incident. Junior members will stay with the apparatus and at no time perform any tasks in and IDLH environment.
- 10) Once a Sparky reaches the age of 16, they will be evaluated and moved up to a Junior Member. This will be discussed with a parent/guardian so they are aware of the changes. As a Junior member, they will then be placed on a six month probation.
- 11) Once a Junior reaches the age of 18, they will be evaluated, given a move up test and then voted upon by the company to move to a regular member. Once becoming a regular member, they will be placed on a second six month probation.
